



## Official 2025 Robert P. Bennett Memorial Scholarship Contest Application

**DEADLINE: April 30, 2025**

### Eligibility Requirements

- No entry fee required.
- You must be a U.S. citizen or permanent resident of the United States.
- You must be enrolled at an accredited two-year or four-year college or vocational/technical school during the 2024-2025 academic year or be a 2025 graduating senior accepted for enrollment in an accredited two-year or four-year college or vocational/technical school.
- You must have a minimum 2.8 grade point average, on a 4-point scale.
- You must be a member in good standing of Unity One Credit Union.
- Employees of Unity One Credit Union, contest judges and their immediate families are not eligible.
- This is a scholarship contest and not a lottery. It is void where prohibited or restricted by any law or ordinance.

### Submission

Applicants are required to submit their application and essay, along with an official transcript copy and Zogo modules with screenshots, through the online portal at <https://unityone.org/scholarships/>. Incomplete entries will be grounds for disqualification. No paper entries will be accepted.

### Essay Prompt(s)

1. What did you learn after completing the Zogo modules that surprised you?
2. Considering your knowledge from Zogo, which is the best and least suitable option when it comes to student loans and provide rationale for your answer.
3. Why is this scholarship important to you, and how would it help?

### Entry Instructions

Please address the prompt(s) in your responses. You may use personal or family experiences to help illustrate your points, along with utilizing information provided by Zogo that is not directly copyright. Be creative. There is no set template for a winning entry.

- Each written response must be no less than 150 words and no more than 500 words in length and must be written in English.
- Only one application may be submitted per person.
- Submissions must be original work and may not be based, in whole or in part, on any previously published, AI-generated, or third party copyrighted material.

All entries must be received by **April 30, 2025**. Unity One Credit Union reserves the right to extend the submission deadline for up to 30 days.

### **Evaluation Criteria**

Judges evaluating the essays will use the following criteria:

- Does the essay address the prompt given?
- Does the essay display originality and creativity?
- Does the essay contain accurate information?
- Does the written essay possess clear writing skills, including spelling and grammar?

### **Scholarship Award**

- One \$2,000 scholarship (1<sup>st</sup> place) will be awarded to the best essay and be paid by Unity One Credit Union to the recipient.
- One \$1,000 scholarship will be awarded to the first runner-up (2<sup>nd</sup> place) and be paid by Unity One Credit Union to the recipient.
- One \$750 scholarship will be awarded to the second runner-up (3<sup>rd</sup> place) and be paid by Unity One Credit Union to the recipient.
- The winner will be notified at the beginning of June. Acceptance of the prize shall constitute permission for Unity One Credit Union to use the winner's name and likeness for purposes of advertising, promotion, and publicity without additional compensation. All applicable taxes are the responsibility of the winner.
- The winning recipient and essay will be published on Unity One's website, including the blog and/or featured on Unity One's social media channels, including but not limited to Facebook, Instagram, Twitter, LinkedIn and YouTube.

### **Evaluation Process**

Employees and Board of Directors from Unity One Credit Union will select the essays that best meet the above criteria. From among these entries, a panel of judges made up of specified employees and Board of Directors from Unity One Credit Union will choose the prize-winning essays. All decisions will be final.

### **How to Submit an Application and Essay**

To enter, you must:

- Complete and upload the required Zogo modules with screenshots
  - "Pay for College"
  - "Understand Student Loans"
- Use the same email address for both your scholarship application and Zogo modules
- Fill out the Scholarship Application Form on the scholarships page
- Answer all required prompts on Scholarship Application form
- Upload current academic transcript
